STUDENTS ARE LIMITED TO ONE STUDY ABROAD AWARD AND ONE INTERNATIONAL FIELD STUDY SCHOLARSHIP FROM THE LUBIN CENTER FOR GLOBAL BUSINESS PROGRAMS DURING THEIR PERIOD OF STUDY AT PACE.

ABOUT THE SCHOLARSHIPS

The Lubin School of Business, through grants received from the Figueroa Family Fund and Eugene and Nancy Celentano Fund, awards scholarships for Semester Abroad and International Field Study opportunities. Those who are offered an award can expect to receive \$3,500 per student for Semester Abroad and \$2,500 or \$3000 per student for International Field Study.

Lubin will also offer one unique scholarship for a Fall Semester Abroad or Field Study course participant. This \$3,500 award is made possible through one or a combination of the Philip and Marianne Bleser Funds and/or Marc Scheinman Award for International Travel. Students will automatically be considered for the single \$3,500 award upon regular application.

WHO CAN APPLY? HOW ARE AWARDS DETERMINED?

These scholarships apply *only* to Lubin School of Business students who are registered in the Lubin Semester Abroad or Field Study experience for which they are requesting aid.

All Lubin School of Business students enrolled in a semester abroad or field study experience are encouraged to apply, however, scholarships will be awarded on the basis of academic merit and demonstrated financial need.

Figueroa Semester Abroad Awards (\$3500) - These scholarships will be available to **Lubin majors** who enroll in a semester-long study abroad experience. Scholarship applicants must have submitted a study abroad application (<u>Quick Steps for Semester Abroad</u>) through the Study Abroad Office. Students will need to have a minimum QPA of 3.0, have <u>completed at Pace</u> a minimum of 12 credits for undergraduate students and 9 credits for graduate students at the time the application is submitted, and filed a 2023-2024 FAFSA with the financial aid office.

Figueroa International Field Study Scholarships (\$2500) – These scholarships will be available to **Lubin majors** enrolled in ANY of the Lubin Faculty-Led courses. Scholarship applicants must have submitted a study abroad application (<u>Quick Steps for Faculty-Led Programs</u>) through the Study Abroad Office. Students will need to have a minimum QPA of 3.0, have <u>completed at Pace</u> a minimum of 12 credits for undergraduate students and 9 credits for graduate students at the time the application is submitted, and filed a 2023-2024 FAFSA with the financial aid office.

Celentano Field Study Scholarships (\$3000) – These scholarships will be available to Lubin majors enrolled in a designated Faculty-Led course. Scholarship applicants must have submitted a study abroad application (<u>Quick Steps for Faculty-led Programs</u>) through the Study Abroad Office. Students will need to have a minimum QPA of 3.0, have <u>completed at Pace</u> a minimum of 12 credits for undergraduate students and 9 credits for graduate students at the time the application is submitted, and filed a 2023-2024 FAFSA with the financial aid office.

Scheinman–Bleser/Figueroa Faculty-led Scholarship (\$3500) – This scholarship will be available to <u>ONE Lubin major</u> enrolled in ANY of the Fall 2023 Semester Abroad or Faculty-Led courses. This student will need to have a minimum QPA of 3.5 and have filed a 2023-2024 FAFSA with the financial aid office.

FINANCIAL AID OFFICE REQUIREMENT!

The Financial Aid Office requires a signed permission form to release your financial aid information to the Scholarship Committee of Lubin's Center for Global Business Programs. This should be submitted as part of your scholarship application.

Please review the following:

- Students are limited to one International Travel Scholarship for Semester Abroad and one for Field Study during their academic tenure at Pace.
- Students may apply for a travel scholarship any semester and must re-submit a new application for each round of scholarship decisions.
- Semester Abroad scholarships will be applied to student OSA accounts.
- Faculty-Led course scholarships will be credited towards the course program fee only. This scholarship will not be applied to your tuition or any other course.
- For Faculty-Led courses, you must be registered for the course for which you are applying.
- Students may not retain any unused portion of their scholarship, redeem their scholarship for cash, or roll-over their scholarship to future semesters.
- Awards cannot be deferred or transferred to a future term for any reason.
- Students may appeal their scholarship determination on the basis of error, but not for reconsideration based on unchanged facts.
- The Lubin School of Business and Pace University retains the right to cancel any student scholarship credit that is awarded based on wrongful information.
