Honorary Degree Citation

Doctor of Laws **Robert S. Tucker** New York City Fire Commissioner

Robert S. Tucker is the 35th New York City Fire Commissioner. A lifelong New Yorker, Commissioner Tucker grew up in Manhattan and attended George Washington University. He went to law school at the Pace University School of Law at night, while working as the special assistant to the late Queens District Attorney Richard A. Brown. The experience allowed him to work closely with an extensive network of executive level members of the New York City Police Department and the City administration, as well as the Federal Bureau of Investigation, the U.S. Secret Service, and other public safety entities.

In 1999, he founded T&M USA, an international security and investigations firm. During his time at T&M, he was also devoted to philanthropic work. This included service as a trustee to the New York City Police Foundation, and on the Board of Directors at White Plains Hospital, Pace University and the FDNY Foundation.

As a 1996 graduate of the Elisabeth Haub School of Law at Pace University, Commissioner Tucker has a deep connection to his alma mater and served on Pace University's Board of Trustees from 2018 until 2024. In 2017, through his generous support, Haub Law established the Robert S. Tucker Prize for Prosecutorial Excellence to recognize individuals who have made outstanding contributions to criminal prosecution and exemplify excellence in prosecutorial practice.

Commissioner Tucker prides himself on being a son of the city, and the father of three children, two daughters and a son. He is the grandson of the late Richard Tucker, an American operatic tenor and cantor long associated with the Metropolitan Opera.

Serving as the FDNY Commissioner is the realization of Commissioner Tucker's lifelong dream.

Jonathan served as Vice President of Haub Law's First-Generation Law Students Association and LAMBDA Law Students Association, demonstrating his commitment to building inclusive spaces and supporting diverse communities. As the Equity, Diversity, and Inclusion Editor for the Pace International Law Review (PILR), he has worked to ensure that articles selected for publication reflect a broad range of perspectives and uphold inclusive, thoughtful language. He has also helped pave the way for future contributors by mentoring first year law students and introducing them to PILR's mission and editorial work.

Jonathan has demonstrated his commitment to community service through a range of hands-on legal experiences. He has volunteered his time with the Welcome Legal Alliance's Refugee Asylum Assistance program, and the Compassionate Release Program, supporting attorneys advocating for federal inmates seeking compassionate release. His recent publications include articles on SEC rules impacting registrants' value chains and clean energy incentives for the implementation of ground source heat pumps under energy savings performance contracts. In 2024, he began interning with the Initiative for Responsible Mining Assurance (IRMA), focusing on improving social and environmental performance in the mining sector.

2025 Barbara C. Salken Outstanding Professor of the Year Award

Leslie Y. Garfield Tenzer

2025 Outstanding Professor of the Year (Full-time)

Professor Tenzer joined the faculty of Haub Law in 1990 and teaches Commercial Law, Contracts, Torts and Social Media Law. She is the Semi-Centennial Faculty Scholar and previously served as the James D. Hopkins Professor of Law Chair from 2019–2021. Her scholarship and teaching bridge the worlds of theory and practice, with a particular focus on regulating conduct in the digital age. Prior to coming to Haub Law, Professor Tenzer was a legislative attorney in the Legal Division of the Council of the City of New York.

Professor Tenzer is a dynamic teacher and committed scholar who brings forward thinking approaches to legal education. She is deeply committed to fostering a culture of justice, equity, diversity and inclusion and has led impactful initiatives in this area, helping to create an all-embracing campus environment in divisive times. A dedicated mentor, Professor Tenzer empowers students as they navigate their career paths, offering both guidance and inspiration. She is the faculty advisor to the Pace Law Review and host of two popular podcasts for students, Law to Fact, and Legal Tenzer: Casual Conversations on Noteworthy Legal Topics.

Professor Tenzer is the recipient of numerous awards, including the Goettel Prize for Faculty Scholarship in 2020 and 2012, the Faculty Award for Excellence in Teaching in 2024, the Ottinger Prize for Faculty Achievement in 2013 and 2004, and the Outstanding Professor of the Year Award in 2014.

Robin Frankel

2025 Outstanding Professor of the Year (Adjunct)

Professor Frankel is a supervising attorney in the Barbara Salken Criminal Justice Clinic at Haub Law. She joined Haub Law as an Adjunct Professor of Law in 2012 and is a two-time recipient of the Outstanding Professor of the Year Award. A career public defender, she began practicing in 1987 in the Legal Aid Society Criminal Defense Division's Manhattan office and currently practices at its South Bronx office. She has tried over 60 cases to verdict.

Professor Frankel serves as a mentor for junior attorneys, externs, and interns. She has created a training on the handling of a felony designed for junior attorneys. Additionally, Professor Frankel has supervised Family Services of Westchester's Juvenile Law Program where she trained Haub Law students to conduct "Know Your Rights" and criminal law workshops for middle-school students. Professor Frankel is a frequent moot and mock trial judge, as well as a NITA program participant at Columbia, Hofstra, CUNY, and NY Law schools. Recently Professor Frankel was responsible for dismissals on two wrongful arrest cases after she successfully convinced the prosecutor that their cases were based on misidentification of clothes. These cases, if not dismissed, could have led to decades of needless prison sentences for both innocent men.
